#### Introduction

So the important work is in shifting the mindsets, emotional states and behaviors to a psychology that will create and deliver performance. However, most businesses focus the vast majority of their energy, attention and resources on the mechanics. The collective psychologies of your people is, of course, the culture. Culture, like brand, is misunderstood and often discounted as a touchy-feely component of business that belongs to HR. It is not intangible or fluffy, it is not enough just to have an amazing product and a healthy bank balance. Long-term success is dependent on a culture that is nurtured and alive.
